## 40 Days for Life

#### 40 Days of Prayer, Fasting, and Vigil for an End to Abortion

From February through April, we coordinated a local 40 Days for Life event. Thank you to everyone that participated.

Before it began, we offered training for anyone wishing to learn how to perform sidewalk counseling. During the 40 days, people held vigil outside the local Planned Parenthood, praying. We sent out emails to participants, keeping them aware of activities and educating them on the issue. Local participants saw the power of prayer this spring. We reached a few women who turned away from Planned Parenthood. One woman even said she preferred to be abstinent after several years of using Planned Parenthood's products.

We hope to expand to more churches and people to participate next fall. It's hard to think of something more rewarding than making a life changing impact in someone's life. #### Iowa Approves Choose Life Plates

The Iowa Department of Transportation (DOT) has approved "Choose Life" license plates. This makes Iowa the 29<sup>th</sup> state to approve such plates.

The plates offer a way to promote life in a manner that is simple and not offensive. For people who don't like bumper stickers, license plates can get the message out there without the sticker. Compared to normal Iowa plates, these initially cost \$25 more, plus an additional \$5 when renewing your registration each year. Proceeds go to the state's road construction fund.

The DOT requires 500 applications within the first year. Iowa Right to Life received 50 inquiries on the day of the announcement.

#### From the Associated Press Stylebook

**Abortion**: Use *anti-abortion* instead of *pro-life* and *abortion rights* instead of *pro-abortion* or *pro-choice*. Avoid *abortionist*, which connotes a person who performs clandestine abortions.

#### The Contradictory Views of the General Public

About a year ago, a study concluded by the Public Religion Research Institute. The study asked questions differently than most prior studies. For instance, rather than asking if someone was pro-life OR pro-choice, the study asked if you felt pro-life described you well, and if pro-choice described you well. Most studies that offer one or the other now shows the majority of people consider themselves pro-life rather than pro-choice. So when it comes down to it, we are the majority. The result of this survey showed one of many contradictions present in the minds of the general public.

When nearly 2 out of 3 people felt

"pro-life" described them well, you'd normally expect 1 out of 3 or fewer to consider "pro-choice" a good description of them. But roughly 70% considered "pro-choice" descriptive of them. The majority of people considered abortion immoral, yet even more people thought it should remain available for at least some situations. Continues on next page

Most people believe Roe vs. Wade should remain, yet the vast majority of people oppose the extremely broad allowance for abortion that Roe vs. Wade and Doe vs. Bolton provided. The two cases decided together allow for abortion for any reason at any time until birth.

Most people don't want to restrict others. So although they consider abortion the killing of an innocent child, and thus morally wrong, they often give in to the idea that they shouldn't impose those beliefs on others. But if we apply that logic to murder and rape, we consider those actions morally wrong, but we enforce laws against the offenders.

Arguments based on emotion, rather than logical reasoning often cloud judgment. Abortion supporters often falsely claim that pro-life people want to put women in prison, when this is not typically true. Even in the oral arguments of the Roe vs. Wade case, Sarah Weddington, who argued FOR legalized abortion admitted that the law she was fighting had not and would not place any women in prison.

Some people form the foundation of their views regarding abortion on these unsupportable catch phrases. Others lack knowledge of the issue or the wisdom to deal with ethical dilemmas in a moral way.

Imagine if your life depended on someone who made the decision based upon the catchiest catch phrase! Although more thought usually goes into it than that, people arguing the issue often resort to catch phrases. The war of words is in full force.

This is why we need to reach more people and discuss this challenging issue. Please attempt to carry out the Pro-Life Challenge described on the left side of this page. We each grow when we attempt a challenge. But when we challenge ourselves in this issue, we can make the world a better place.

If people knew what Roe vs. Wade legalized, most people would oppose it. If people understood the circumstances surrounding most abortions, they would oppose the majority, if not all abortions.

At first, the issue seems difficult to bring up. But over time, one finds it's easier to discuss than you'd think. Remember, when deciding between pro-life and pro-choice, the majority of people side with life. It's the greater priority.

When the average person already agrees with you in general, they listen more receptive to what you have to say. People are curious by nature. With a little information, fewer people will remain conflicted. When more people build upon a solid foundation, it should yield changes that further support life.

Over time, this newsletter should cover much more regarding ways to defend the life-affirming position. Some people have already read the defense in the so-called hard cases. This newsletter can further expand upon other circumstantial cases. We can examine the flaws in the different views on when life begins.

While this newsletter aims to educate you about the issue. Please, pass along the knowledge you gain. Knowledge does little without applying it.
