One More Point

In last month's article about the hard case to save the life of the mother, a point was missed. Many people argue that children should be wanted. In some cases, not being wanted is enough to justify abortion

for some people.

When the life of the mother is used to justify abortion, it's likely she wants to keep her baby, or she would have aborted the child sooner. For people who rally for

"choice", they should acknowledge that the mother wants to keep her child. Only when not given all the information about all alternatives does the uninformed choice shift to abortion.

Hard Cases – Fetal Deformity

In recent months, we've covered various so-called "hard cases" often used to allow abortions in special cases. Many pro-lifers oppose abortion in most cases, but struggle with some of these exceptions. We hope it's been helpful.

Last month, we covered the life/health of the mother. This month, we focus on the child's health. Some people justify abortion in cases of fetal deformity.

Michael Clancy points out in his public appearances that

tests for spina bifida, a sometimes fatal condition, sometimes reports a false positive. Like most prenatal tests, they aren't 100% accurate. If we allow abortion for such cases, we permit killing children under false pretenses.

Some deformities aren't very significant. Once we allow abortion for some deformities, we open the door to others. The range of conditions is like shades of gray. Where does it stop? We quickly revert to Eugenics, seeking what we

think is perfection and killing anyone that doesn't measure up. This never ends well, since no one is perfect.

Genetic tests could point to possible future ailments. What if tests suggested your child might experience a degenerative disorder later in life? Do we take a life now to avoid a mere possibility of future problems? This prejudges the lives of children and assumes there won't be a cure by the time the child might exhibit the

This spring, four Planned Parenthood facilities closed in Iowa. This was huge!

40 Years - Legal Abortion

Although the end of the 40 years of decriminalized abortion occurs in January, that 40th year began this past January.

40 Days for Life Expands

New locations began 40 Days for Life in Iowa this year. Locally, we continued to grow our numbers.

Abortion Numbers Down

Although recent reports suggest national abortion numbers dropped significantly, Iowa reported good news. Although the latest numbers come from 2010, they showed a drop of over 18% in the number of abortions since the state had their first 40 Days for Life activities, just 2 years earlier! That's not a trivial drop.

symptoms.

Some of the happiest people seem to be people with deformities. Their parents usually exhibit an amazing amount of love. But love involves giving and putting the needs of others ahead of your own.

Sometimes, people fear the amount of effort or money it will take to raise such a child. We deny ourselves a lifetime of love when we end life before its natural end.

Disabilities shouldn't be looked down upon. Other than bringing great joy and love into our lives, even employers often prefer disabled employees. In general, they work hard and rarely compare themselves to others or argue over little things.

We all have strengths and weaknesses. We shouldn't kill people for their weaknesses. If abortion is acceptable for preborn children with disabilities, and if abortion is not acceptable for other cases because it takes a life, then

the same justification to abort would justify the taking of life after birth.

Some people want to avoid unnecessary suffering. They think that abortions will spare the parents and the child from suffering as the child dies prematurely. If the child will die soon anyway, there is no need to implicate oneself in the death. Some parents find great healing and peace by having a chance to meet their child, allowing a natural death.

A recent article reported that a child lived after being born below the minimum weight of 1 pound typically demanded. A pair of scissors remained on the scale, enabling the weight to achieve the minimum weight. The error was caught later, but the child lived. Too often, we give up on challenges. How many more lives could be saved if we tried? How many more diseases/conditions could be cured if we sought to cure rather than resorting to killing?

Abortion is not as safe as live birth, despite what some people have claimed. It also leaves lasting mental and physical problems for many women. While focusing on one form of suffering, people often overlook the suffering they are rarely warned about.

Many people have twisted the purpose of prenatal tests. Prenatal tests taken to determine whether a child should live or die, determining the value of the child are wrong. However, when the risks of the tests are low enough, they can help parents prepare for the challenges ahead. Note that some tests have a higher rate of complications than the typical rate of the thing they test.

We should see value in every human life, helping others in ways that meet their needs, while others help us to meet our needs. We can avoid suffering from our own decisions. We should use tests to prepare for challenges, not to determine the value of life. There are so many opportunities to value life. Respect the lives of all people, and we can bring out the best in us all.
