Webcam Abortion Ruling 8-2: What Results?

Four More Closings!

On December 12th, Planned Parenthood will close four more facilities in Iowa, including:

- Ankeny
- Fort Dodge
- Mount Pleasant
- Washington

In less than two years, 10 facilities closed in Iowa alone, leaving only 16 facilities.


But closings keep happening nationwide. The map shows closures from recent years in green. Surgical abortions appear in red, while medical/webcam abortions appear in yellow. Other Planned Parenthood facilities appear in blue.

With roughly 40% of

their facilities closing in so little time, the opportunities to see more close remain high. But facilities don't close themselves.

People need to hear from you

what really happens at these abortion facilities. Pregnancy Support Centers need your help. We need every helping hand and voice.

Webcam Abortion Ruling

In late August, the Iowa
Board of Medicine heard
public feedback regarding
webcam abortions. Soon
after, voted 8-2 in favor of
rules that prohibit the
current practice. But,
Planned Parenthood, the
organization that invented
the webcam abortion made
it clear they would fight the
new rules, and did.

The rules should have taken effect in November, but a judge delayed enforcement. So prayers are still needed, since abortions still take place locally. And with their appeal to repeal the rules, the fight for life is not over.

People across the state united in prayer during the public hearing. Some people emailed feedback, while others testified in person. Many concerns were voiced.

A prior Planned Parenthood employee

made it clear that the staff members performing the ultrasounds and exams aren't properly trained. Others pointed out the risks of dispensing a deadly drug far from any medical help, should things go wrong. Women often want to hide their abortions, so unlike complications from medical procedures, the odds the women will not only figure out how much blood and pain is normal, but also call for help and get help in time seems less likely than it would be for non-abortion complications.

Despite these and many other concerns, Planned Parenthood is determined to maintain their ability to perform abortions statewide, rather than just in cities that have larger populations. Cities not only provide enough population to provide them enough demand, but it also



makes it economical for their abortionists. It's hard to be an abortionist in a small town with little clientele. As already pointed out, it's those rural areas that webcam abortions reached that also lack hospitals equipped for the complications of webcam abortions.

Planned Parenthood seems to trivialize what they call the "miscarriage experience." Women who have had miscarriages know they are difficult and complications do arise.

Don't become complacent when Planned Parenthood loses ground; they work hard to reclaim lost ground.

Obamacare Changes Rolling Out

The Affordable Care Act that passed into law a few years back delayed implementation of its many parts. With the complexity of the law, it was considered too complex for most people to figure out what they needed to know.

To address the complexity, "navigators" were chosen to help people navigate through the implications of the law. Planned Parenthood of the Heartland received over \$200,000 to serve as one of three in the state of Iowa. Since then, the local Planned Parenthood added 7 hours/week, and they are open on Thursdays again.

Critics point out that the implementation of the navigators will occur so rapidly that the proper background checks and privacy safeguards won't be in place. This means that employees at the most protested abortion provider in the nation will have access to tax records, social security numbers, and medical records of



American citizens.

With this and other changes, training has begun at the local Planned Parenthood, drawing in trainees from across the state and region.

We can hope there won't be an abuse of power, now that Planned Parenthood could access information on a wide range of people.

The so-called "death panels" that were denied while the bill was debated in Congress have been acknowledged as reality. Rationing healthcare will affect the elderly and disabled the most. We

often focus on life in the womb, but this brings us to the other end of life.

Many people have already lost their health coverage as employers reduced full-time employees' hours to part-time. Others lost the plans they previously signed up for, since they are no longer available.

Watch for more changes as more of the Affordable Care Act rolls out. It's important to understand the implications that have already begun to pop up as people realize what was in the lengthy law.
