Two More Planned Parenthoods Close!

On May 31st, after praying outside the Cedar Rapids abortion facility, I stopped at a grocery story on my way home. My shopping was interrupted when my cell phone rang. It was Rod Goodemote calling. Although most people in Cedar Rapids won't know Rod, I knew he was the leader of 40 Days for Life in Red Oak, Iowa.

A few years earlier, he was living in Florida, and was about to move back to Iowa. Someone in Iowa was trying to convince him to lead 40 Days for Life. I chimed in to help recruit him. He accepted the responsibility, even though he would still spend the next month in Florida before having about a month to prepare in Iowa.

People often say they are there to help, but don't always follow it up with action, and I didn't want to be that kind of person. So Rod and I spoke and emailed back and forth several times. He reached out to media more than we do. Volunteers



there were mostly Protestant, while most of those in Cedar Rapids are Catholic. He was leading outside an abortion facility in the smallest community that provided abortions in Iowa, while we are in Iowa's second-largest county. Despite the differences, there were many things we were able to share with each other.

Rod knew people in Creston, which also had a Planned Parenthood that committed abortions. Over the past few years, he would play a major role in recruiting a leader for Creston's 40 Days for Life effort. They finally joined in this Spring.

Back in December, we heard that both Red Oak and Creston Planned Parenthoods reduced their hours to zero, but they still accepted clients by appointment. We wanted to declare victory, but we knew not to do so too soon. A few months later, a CLOSED sign went up, making it seem even more likely that victory could be declared. But again, they were still Planned Parenthood facilities that indicated the possibility of offering abortions.

Well, when Rod called me, he was telling me that a sign went up on the door. The Red Oak Planned Parenthood was "consolidating" with an existing location, which means they were closing. He was going to have someone check Creston. A while later, we found out that Creston was also slated to close on Wed., June 18th!

We praise God for the great things happening in Iowa! The only Planned Parenthoods west of the Des Moines and Ames metro areas are in border towns. Roughly HALF of the Planned Parenthoods have closed in just 2 years!

PP's Jill June Retirement

After 30 years with Planned Parenthood, Jill June will retire at the end of June. Abortion advocates honored her earlier this month.

Under her leadership, what is now Planned Parenthood of the Heartland went from having 7 facilities to several dozen. But much of that growth came from mergers. As we have been able to report regularly in the past 2 years, many facilities have closed.

Jill received Planned Parenthood's "Stick Your Neck Out" award. She failed to cooperate with a subpoena by blocking access to information requested by a county attorney that needed information for a case. Efforts to obstruct justice and not seek some reasonable solution was championed by abortion advocates.

But many years later, when Planned Parenthood faced a multi-billion dollar lawsuit raised by a former employee, they demanded to see evidence, which would have required a similar disclosure of patient information that they prided themselves a decade earlier for protecting. In this case, it would have required thousands of violations of federal laws in order for the whistleblower to release such information. The double standards were plentiful under Jill's leadership tenure.

Planned Parenthood of Greater Iowa merged with the affiliate that included Nebraska a few years ago, and then took on the name Planned Parenthood of the Heartland. Then, they merged with Planned Parenthood of East-Central Iowa. The Cedar Rapids facility was the main facility in the acquisition, but it had struggled to sustain the losses from the Dubuque operations. Without the merger, Cedar Rapids and Dubuque may have both been free of Planned Parenthood by now.

Soon after that merger, they acquired the affiliate in Southeast Iowa, and then facilities in Arkansas and



Eastern Oklahoma. This merger made the territory noncontiguous, since Kansas and Missouri were not under Jill's leadership.

Jill originated the concept of webcam abortions, and she would strive to spread it over this vast new territory. Many states rapidly outlawed the practice, but Iowa kept it legal. The Iowa Board of Medicine banned the procedure, but Planned Parenthood fought and successfully convinced a judge to put a stay on the ban.

We want the best for women and children in Iowa. Therefore, we hope to see more facilities close under their new leader.

It may not be too late If you've taken the abortion pill it may not be too late. Call 877-558-0333 right away. We can help you!


> Prayers work anywhere. Help is more readily available than many people assume. We are thankful for your prayers locally, and for the help in this case from our friends in Dubuque.
