Marches for Life: Iowa & National

Then the marchers circled the capitol building and marched to the state Supreme Court building. The picture above shows the line of pro-lifers on their way, plus several that already made it to

Hundreds of people gathered for a lunch after the outdoor portion of the march.

Speakers gave moving speeches during the meal.

Josh Brahm helped attendees understand how to more effectively discuss the pro-life stance with other people. The content of the arguments mostly focused on the equal rights argument. But the tone and

approach to the argument followed the respectful and loving approaches that align well with the Bible. Afternoon breakout sessions concluded the day with even more great speakers.

Legislative Update



To keep people informed on legislative activities, we include the following updates on bills introduced in the Iowa legislature and Congress.

<u>Iowa</u>

"Death with Dignity Act."
It uses the compassionate terms to justify the ending of life in an unethical manner. It appears to build off the Brittany Maynard case by attempting to make legal in Iowa the same type of law that led to her death. Despite the bill denying the dignity of human life, it does include requirements for informed decisions, a waiting period, and other

things we usually see in prolife laws that aim to protect life.

HF58 adds a requirement to perform an ultrasound before abortions. It also requires the expectant mothers the opportunity to see the ultrasound. They may decline. Ultrasounds are credited with saving many lives, since most parents choose not to abort after seeing their child. Ultrasounds are already common practice before abortions to determine the gestational age, which sets the price for the abortion.

SF55 prohibits funding of abortions from the Affordable Care Act


(ACA.) An executive order proved to have no weight in preventing the funding of abortion in insurance plans

and exchanges. This bill attempts to prohibit the funding of abortion through such plans.

Federal

The House of
Representatives planned to
vote for a pro-life bill on
the day of the National
March for Life. The
original bill was supposed
to be the Pain Capable
Unborn Child Protection
Act. There was
disagreement regarding the
terms within the bill.

The House chose to vote and approve the No Taxpayer Funding for Abortions act. The other bill will come up again at a later date.

40 Days for Life starts
Wednesday, February 18 and ends on Sunday, March 29.
Many of you have expressed the desire to learn how to more effectively communicate the pro-life message when people approach you while praying. Our kick-off event will address this.

The event starts on Sunday, February 15 at 2:00 p.m. at St. Patrick's Parish Center. We will show the *Making the Case for Life* DVD and include other information useful for

40 Days for Life. This could be our most useful training of the year! Don't miss your last chance to get such training before 40 Days for Life begins!

The most visible part of 40 Days for Life is the peaceful prayer vigil. We pray outside the local Planned Parenthood facility. We remain peaceful, respectful, lawful, etc. God can do all things, and we call upon His divine power to convert the hearts and change

minds in our community. We pray from 7 a.m. until 7 p.m. each day for 40 days.

A less visible component of 40 Days for Life is fasting. There are many ways to fast, but people most commonly fast from some form of food. The Bible makes it clear that some

evil can only be cast
out or overcome
through fasting. The
Bible also states
"when you fast"
rather than "if you
fast." It's not
meant to be a
question whether or
not you fast in life,

but it's an expectation.

Fasting brings transformation. Remember to fill the void with something good. Some people fast from TV and fill it with more time praying to end abortion. Fasting is strongly encouraged, but don't do anything so extreme as to negatively affect your health.

Come to our kick-off, and invite friends to join you at our prayer vigils.
