The primary image above this article shows consecutive emails I received. The email from Planned Parenthood calls people to break someone's heart. The email received less than 30 minutes earlier aims to help people with dialogue in situations where it's difficult to address controversial matters. While one tries to attack others in hurtful ways, the other seeks civil understanding, which allows us to learn from each other.

When I look at many of the posts from Planned Parenthood's Facebook page for drawing their supporters to political action, I see strong emotional triggers and misleading information. When the anger emoji is the most

common reaction for so many posts, you're probably following a page that's feeding anger. This is not only present on pages that support abortion access. Pro-life pages that elicit similar reactions consistently lead me to lose interest in them.

It can be easy to play with people's emotions. Much of today's marketing depends on it. But we need truth and love, or lies and violence result. We have seen "pro-life" people who killed abortionists or performed other anti-life actions. They never connected with existing pro-life groups, who tend to recognize the importance of sowing the seeds of peace, love, respect, etc.

It is irresponsible to draw people to anger so consistently. Yes, there is a time for righteous anger, but tempered with the proper ways to turn that into productive action. What would you prefer to motivate you? If you could read about people who love life, save lives, and sacrifice for the benefit of others, I suspect you would like that. But if we always wrote about killers like Kermit Gosnell, the areas where people are dying, etc., I suspect you would be saddened, depressed, or wanting to lash out in some way. We try to offer a balance so you see both good and bad. We seek truth and love in response.



Government Update: Session Continues

Iowa

Senate File 2281 (SF2281) passed the Iowa Senate on Feb. 28th. It will move on to the Iowa House. The companion bill, House File 2163 (HF2163) has remained in committee. Both bills will protect life once a heartbeat is detected in a preborn child. It's an election year, which makes it harder to pass controversial laws, and other states have been unable to enforce their laws yet.

HF2162 prioritizes abortion providers lower than others for educational grants, which would get them out of most schools. Planned Parenthood has been very busy in our schools in Linn County. So this is important, and it gets businesses that profit from the failures of bad sexual

education programs away from our children.

Senate File 335 (SF 335) and House Study Bill 569 (HSB 569) sought to reinstate the death penalty for certain offenses. Both bills have stalled in their respective legislative chambers.

California

SB320 aims to force college campuses to carry and dispense abortion pills. It has already passed the California senate. It's often important to watch what happens in California, since it often leads the way in laws that make abortion more accessible. Planned Parenthood has made it clear that it plans to push many bills in several states. They are trying to build

grassroots support. This year's elections could determine their success for a few years.

Washington (state)

The state of Washington is very likely to end their use of the death penalty. SF6052 has passed their senate and could pass their house any day now. Their governor put a moratorium on the use of the death penalty a few years ago, so as long as it passes the house, it should become law. Their session ends just a week into March, so this is coming up fast.

Nation

Taxpayers continue to fund Planned Parenthood, due to the inability of the Senate to take action on the matter.

We get in some prayer. Then at 6 pm, we head to Godfather's Pizza to share a meal together. We provide the pizza and non-alcoholic drinks. We always accept a free-will donation, and we are grateful for everyone's generosity.

I Lived on Parker Avenue

A 30-minute film short will become available on March 8th. The movie is called, I Lived on Parker Avenue. I had the privilege to preview it this past summer at the National Right to Life Convention. The official movie synopsis is as follows:

Adopted at birth and raised in Louisiana, David Scotton is on a journey to Indiana to meet the birth parents he's never known. His tattooed birth mother, Melissa, and reserved birth father, Brian, anxiously wait for him, concerned David will reject them for decisions they made before he was born. I Lived on Parker Avenue is a short documentary about mother's agony choosing what's best, the joy of a couple starting a family, and a young man's search for where his life began.

The story is very touching and it is very uplifting. We see the

good that can come from entrusting a child to adoptive parents who can provide what one might otherwise not be able to provide for the child.

Gosnell Movie

The producers of the Gosnell Movie are very close to making an announcement about its release. This movie is a feature length movie, which I also had the privilege to preview at the convention this summer.

The movie tells the story about how the drug enforcement agents were led to abortionist Kermit Gosnell and the horrors they found. It shows the terrible conditions of his abortion facility, where he became our nation's most prolific killer. He killed countless

children after birth in the privacy of his abortion practice. Women were severely injured and died. The state failed to hold Gosnell to minimum health standards. They didn't inspect his facility for a very long time.

I was amazed at how the film was able to covey someone who performed such terrible acts of evil in a way that made it known just how terrible it was, but without showing anything gruesome. In some ways, it reminded me of the way older films would have the camera turn away as something bad was about to happen. In the court room, we don't see the image of one of the many babies who had the spine severed after birth...we see the back of the image being held up for the jury. We instead see their reactions, which were their real reactions. They didn't bother with a second take for that scene.

We will inform you once this movie has a release date.
