New Mexico is drawing attention as a state seeking to push assisted suicide in a direction far worse than ever before. The bill has not become law, but it's something we need to keep an eye on.

The law would allow the same technology that enabled webcam abortions to dispense the drug used in assisted suicide. Evil loves to reuse ideas to bring about death in other situations.

The danger is even greater since the bill lacks any residency requirement. This could lead to sites lining the border for visitors to get quick access to the deadly drugs from satellite facilities that link to a more central person who could dispense the drugs remotely. This could become big business for a doctor, but one doesn't have to be a doctor, due to the next point of concern.

Not only does it put physicians in a position of bringing about death, rather than aiming to restore life and proper function, but it spreads the authority to nurses. It's bad enough that people in both professions might become accomplices in providing lethal pills to someone who then takes his/her own life. But the bill would not require the victim to administer the drug. That means someone else can administer it. That's euthanasia where one person kills another.

Even other states that allow this deadly practice use the same 6-month standard that hospice uses (although California might extend). But this bill uses vague terminology, such as anticipating death in the "foreseeable future". Everyone I know should be dead within the next 120 years or less. Is that foreseeable enough? The waiting period is just 2 days. Now imagine that one person is enough to make the assessment. A second opinion is not required.

Like many other threats to conscience, this bill will require a medical provider who does not wish to implicate himself/herself in the killing of a person, to refer to someone who will do so. It would be like calling a suicide hotline and if the people asked you to help them carry out their demise, you'd have to point them to someone who will comply.

Upon death, the death certificate will misleadingly refer to the prior affliction as the cause of death. Life Matters: A Coalition for Life of Iowa Newsletter

Government Update: Roe's Stranglehold

Federal Government

While the federal government was shut down, there were still efforts to restore funding to abortion providers. After the President previously cut funding to international abortion providers, there was a shrinking of such global organizations.

With the extension of 3 weeks to work out a new deal, there's still a chance the proposers of the next bill might try to inject such funding.

Iowa Government

A judge struck down the Iowa Heartbeat Law. Rather than aiming for a timely ruling, he chose to issue the ruling on the anniversary of Roe versus Wade. This really suggests the presence of political bias. The judiciary is not there to promote a certain cause over another. Yet he aligned the timing of his ruling with such a notorious prior ruling.

Appeals are being considered, but the path forward has not been decided yet. Several states have introduced similar legislation, following Iowa's lead.

Other States

New York just became the most radical state with regards to abortion law. Their governor demanded from the legislature a bill that would allow abortions up to birth. Until they met his demand, he would not approve any budget bill for the state. The vast majority of lawmakers in New York look favorably on abortion, so they acted quickly. The governor of New York quickly signed it into law with cheering, applause, and even some laughter. The law took effect immediately upon signing.

He further requested that various landmarks, such as the World Trade Center tower light up pink to celebrate the passage of the law.

Roe has a grip on far too many lawmakers.

The other states that have little or no restrictions on abortions: Colorado, Washington D.C., Oregon, Vermont, and New Hampshire.


Pro-Life Billboard Winners!

Controversy at the National March for Life

The media used to largely ignore the National March for Life in Washington D.C. Then they started to twist the details. Some of them would make the numbers of pro-lifers sound hundreds of times smaller than were there. Some of them have been completely deceptive in the past.

This year brought the opportunity for a distraction. Rather than having to comment on the March for Life itself, the media focused on a video that went viral on the internet. The video shows a Native American in very close proximity to a student, who is among his classmates after the National March for Life. Most people saw at least a headline or caption before watching the video, which led many people to see a student that was blocking the Native American man, looking like he thought he was better than the older man.

I watched the video, having seen the headline. Then I watched it again, watching for the key people that stood out from the first watching. It was very easy to see that the initial reports mischaracterized the situation. I saw how the man walked through the crowd, finding gaps between people, until he changed direction and headed right for the student that would become the focus of the internet for several days. I saw no attempts to move around the student. The odd look on the student is common for people who are faced with situations like prolifers sometimes face, where someone approaches with unknown intentions.

The elder's story changed when more videos came out. His story then conflicted with his first story, and still didn't make much sense for the situation he was in. More videos revealed just how well many of the students handled the situation—especially the student that was mostly trashed by people when the video went viral.

Don't just trust what is reported. Seek truth.


