# Planned Parenthood CEO Fired!

Planned Parenthood's upper management continues to have high turnover. Cecile Richards stepped down from her role as CEO last year. Another executive resigned a few months later.

It took Planned Parenthood many months to find a suitable replacement for their CEO. They eventually named Doctor Leana Wen to the post in September, but she wouldn't take that position until November. She was the first doctor to fill the CEO role in half a century. But Planned Parenthood is mostly political in order to keep their lucrative \$1.9 billion business going.

She brought some boldness when she made it clear that Planned Parenthood's core mission involved abortion. Planned Parenthood had attempted to avoid admitting that in the past.

She was hit with serious challenges early on. This made her speak at public rallies. This is just a personal opinion, but it seems like Leana may naturally be more soft-spoken. But Planned Parenthood thought they needed a loud and powerful leader. When Leana tried to convey that power and volume, she came across as angry and/or mean. This is not a good image for Planned Parenthood.

Near the end of her time as CEO, Leana wrote of her miscarriage experience. This had the potential to really draw in people from the general public to see her as a real person and to focus on reproductive health. But she referred to baby number two at one point, which had to draw the attention of the Planned Parenthood board. She recognized a child in the womb as being her baby. If nothing else would limit her days at Planned Parenthood, that likely did.

But she was a doctor and wanted to focus on things that address health issues. That's what Planned Parenthood should have wanted when they sought a doctor. But they seemed more interested in gaining the benefits of having a real doctor running the business, but not listening to her or prioritizing her goals. The Planned Parenthood board of directors wanted a strong focus on abortion, especially now that they think their ability to perform abortions could be in danger. There was a sharp divide that ensured Leana wouldn't last long. She only lasted eight months in her role as CEO of Planned Parenthood.

Alexis McGill Johnson now serves as the acting CEO who replaced Doctor Wen. Alexis is just temporarily filling in until Planned Parenthood can find a new CEO. Alexis has served on the boards of Planned Parenthood's political organization. Who better can serve as the head of a business claiming to be about health than someone focused on politics?

This is a bad time for Planned Parenthood to lack stable leadership. Going from Cecile to Leana to Alexis to her eventual replacement in barely more than a year looks bad for them.


# School Shopping


These alternatives work for any kind of shopping. But we know more school shopping occurs within the next month.

We thank everyone who participated in our survey earlier in the summer.

More than 80% of the responses indicated opposition to abortion in all circumstances. Most of the other responses made an exception for the life of the mother. The rape and incest exceptions had the lowest number of responses.

Everyone answering the survey affirmed there is no right to die through assisted suicide.

End-of-life plans are for the benefit of your loved ones and to make sure you are treated in accordance with your wishes. Roughly 80% of the respondents indicated they had a will. About 40% had medical advanced directives or the medical durable power of attorney. Only about 20% had funeral plans made out. Did you know it's free to make funeral arrangements? We know we will all die sometime.

As is typical of pro-lifers, we saw the most interest in abortion-related subjects. There was also a vast majority of people interested in learning effective ways to counter the pro-abortion stance.

In response to this, we plan to provide a pro-life apologetics course. It's available online. But we also find value in having time together to discuss the lessons and to practice a little among other pro-lifers. People who are interested can gain access early by contacting us. We hope to have the in-person part in this spring and early summer.

This also goes a long way toward opposing Planned Parenthood (PP), which many people showed interest in. PP is our nation's largest abortion provider. They continue to get into our schools, despite their system proving to offer zero net benefits.

End-of-life decisions also had the interest of at least 70% of respondents. We will look into the best ways to serve our members in this area.

## More PP Sites Close

Planned Parenthood of the Heartland used to include Arkansas before they split that off again and merged with the affiliate to our north. There is good news out of Arkansas. The Fayetteville Planned Parenthood site closed.

This means Arkansas no longer has an abortion provider anywhere except for a few sites in the Little Rock area. One is a Planned Parenthood that provides the abortion pill, and the other is a surgical abortion site that is not part of Planned Parenthood. The Fayetteville site served the NW part of the state, as well as anyone in SW Missouri or part of the NE part of Oklahoma. They are struggling to find a new location. We hope they don't find a place to open.

Muskegon County in Michigan used to have a Planned Parenthood in the same building as their county health department. People successfully convinced their county to kick Planned Parenthood out of their government health building. They are also looking for a new location and struggling to find a good location.

We know what it's like to have an abortion provider looking for a new location. When we started praying for 40 days in local churches (before we started 40 Days for Life outside of Planned Parenthood), the Cedar Rapids Clinic for Women closed. They wanted to stay in business, but no longer at that location. We were concerned about where they might end up.

For a while, it looked like they might end up in Wellington Heights, in the vicinity of the old Planned Parenthood location. It also looked like they were going to set up shop within sight of what is now called Bridgehaven. They had some issues, which messed up those deals. As each month passed, it seemed more likely they wouldn't reopen, since their normal clients would find other providers, and they should run out of money.

After the 2008 flood, we found out they had given up finding a new location, so they retired. Please pray that these abortion providers won't find new locations.

The Saint Louis Planned Parenthood was granted an extended time of operation while they waited for their next court date in August. All eyes will watch what happens in Saint Louis in the month ahead to see if they will be allowed to continue performing abortions. If they are, then the courts will override the regulators. If they aren't, then Missouri will be the first state since the 1970s to go without an abortion provider.

Residents of Missouri will only have to go a few more miles to reach an abortion provider in Illinois. There's also a provider in Kansas City. So abortion will still be accessible, regardless.


