This time of year offers multiple ways to make a difference in the pro-life movement. One that's coming up this weekend is Life Chain.

Life Chain is one of the easiest ways for someone to make a difference. It's often a great way to get someone involved, since it happens just once each year. We pray along a visible stretch of road, in our case, 1st Avenue/Williams Blvd. While we pray, we hold signs with pro-life messages that have saved lives before. This year, we will gather at Trinity Lutheran Church before disbursing to our designated blocks on the West side of town. We hope people come a bit early so we can head to our blocks around 2 pm.

Last year, we spanned roughly 1.3 miles with hundreds of participants. It was remarkable to see a line of signs and supporters in what seemed like a never-ending line. We want to continue to grow this event. So please come on Sunday, invite friends, and bring others with you.

We are in the midst of 40 Days for Life. Although people can choose to pray for just one of the 1-hour time slots, many people choose a weekly 1-hour time slot or come back when they can. If we had everyone who participated in last year's Life Chain filling vigil time slots in pairs, and if they repeated this weekly, we could cover every time slot in our vigil.

It's even better if we help draw more people to participate. As great as it is to see people fill every time slot, the more people who participate, the easier it is to keep time slots filled going forward. If we had so many people that we could fill all time slots by participating just once for one hour, just imagine how great it would be to come back weekly and just have that many more people present!

40 Days for Life has saved thousands of lives, including some lives locally. It's really easy. Like the Life Chain, people pray. They usually hold pro-life signs, but they don't have to. I prayed on this past

Saturday with no sign, and I really got a lot out of the prayer time. But signs have also helped save lives and let people know why we are out there.

One thing that people sometimes struggle with and sometimes fear is when someone tries to talk about the abortion issue. Many people don't know how best to defend the pro-life position or make a good argument for the pro-life position that changes people's minds. This is where pro-life apologetics comes into play.

Yes, there are people who have spent hundreds or thousands of hours refining their arguments and methods. But there are some tips that take minutes or a small number of hours to learn. I've used such methods and changed minds before. There are several programs to learn from, but my favorite is the Equal Rights Institute's Equipped for Life course. We trained some members last year, and we would like to do this again in the year ahead. We must do our part to change minds.

Government Update

National

The U.S. Supreme Court agreed to hear the Dobbs v. Jackson Women's Health Organization case that will directly challenge Roe v. Wade. Please pray about this case until the ruling. We want the best preparations beforehand, the justices to hear the best arguments, and the most justice in the ruling that they will work on through June.

The U.S. House has passed a bill that would make abortion legal for any reason up through birth. It should not pass the Senate.

Texas

As of September 1st, Texas has successfully enacted a pro-life law that protects life from the moment a heartbeat is detected. Several other states passed Heartbeat Bills into law before, including Iowa. Whenever pro-life laws are passed, the abortion industry usually gets some judge to put a stay on the enforcement of the law. This kept our own Heartbeat Law from going into effect.

Texas tweaked the typical Heartbeat Law in a way that made it hard to put a stay on it. Even Chief Justice Roberts considered it unprecedented when he wrote about it in his dissent from the overall court decision to NOT put a stay on the law's enforcement (which means his position would have led to the law not going into effect). But there is precedent in California where they allow people to do something similar if they spot a toilet stall that doesn't meet the American Disabilities Act (ADA), whether or not they are disabled. In the Texas case, anyone could sue anyone other than the mother of the child being killed in the abortion for their part in the abortion.

This made it so the abortion lobby couldn't sue the state, since the state doesn't enforce the law. They would have to sue the average person, if not all people of Texas.

<u>Iowa</u>

In the midst of the uproar about the Texas law taking effect, a case we've kept our eyes on for a few years reached an unfortunate conclusion. It appears that the case Sue Thayer made against Planned Parenthood (PP) defrauding the government has failed.

There was a lack of proving intent to defraud the government. In the end, it was acknowledged that some things were coded incorrectly in the little evidence provided. However, the judge thought they could have made an honest mistake, and intent was not proven.

No further action was expected. The odd thing is that if things were coded incorrectly and the amount of over-charging could add up to tens of millions of dollars, the government still ends up having overpaid. But this is a civil case, and like the Texas situation, there's a big difference between a case involving the government and one that deals with two other parties.
