## 2023 Year in Review

This was a very different year. Is the first full year since Roe vs. Wade was no longer in effect.

I personally felt less involved with the local activities for a few reasons. I attended the National March for Life, so I could see what all they would do for the first post-Dobbs march. So, I missed the local March for Life. I had family matters come up that took me away from local activities at times, and I even missed our local Life Chain.

As for the group as a whole, those events went very well. In midsummer, Planned Parenthood identified a few sites in lowa where they could close temporarily, and instead closed two of the three permanently. At the same time, they announced that the Cedar Rapids site would resume committing abortions. But before they had a real chance to do that, they temporarily closed the

Planned Parenthood site that's here in the state's second-largest city. It will end this year remaining closed. I believe the first day we knew they were closed was September 8<sup>th</sup>. If so, then they have been closed during the last 114 days of the year if they remain closed until the end of the year.

Iowa's Heartbeat Law was ruled upon in an unfortunate tie ruling, which left it not being enforced. Then, a special session of the Iowa legislature passed it again to address the unusual claims of the court that it was just "hypothetical" law. That made me concerned about some of the justices that presently serve on the court. But now they have "real" law that was passed when it COULD take effect. But a judge put a stay on it, as usual. So it will take more time, effort, and money to see whether the law will ever be enforced.

It's been 10 years since Kermit Gosnell was convicted in Philadelphia. It was after that ruling that many states pushed for better laws to prevent another butcher from being able to get away with horrible crimes for so long, including murder. However, in the wake of the fall of Roe, several states have eliminated virtually all protections, not just for the lives of the children, but for the health and wellbeing of their mothers, and basic, minimum standards that can lead to problems like we saw with Gosnell.

After the rather pro-life state of Ohio voted to amend their constitution to provide a right to abortion, there are efforts in many other states to do the same. Florida is likely the biggest target for the year ahead, as is the state of Nebraska. We need people to protect life!

# Government Update

#### **Iowa**

In November, Iowa's Attorney General filed an appeal to allow the Heartbeat Law to go into effect, again. It was only allowed to be enforced for a few days before a Polk County judge put a stay on the law. The Iowa Supreme Court has agreed to hear the appeal.

The prior Heartbeat Law was passed several years ago, and it spent years in the courts. It's good to see that this is already being elevated to the state's supreme court, since much of the delay in legal cases arises from the various levels of courts and appeals.

The last appeal on the prior
Heartbeat Law ended in a tie ruling,
which allowed a lower court's
ruling to stand, thus preventing
enforcement of the law. But that tie
resulted from a justice not making a
ruling, based on her employment
with a company that represented
one of the sides when the matter
was argued previously. This law
should avoid that, and we hope for a
good outcome. Now it's a matter of
when hearings and rulings occur.

#### **Minnesota**

The Minnesota legislature is poised to pass a law legalizing assisted suicide in the coming year. This past year, they stripped practically all protections for life and health for the child and mother in cases of abortion, making Minnesota radically pro-abortion in law. Now, they aim to do the same with matters at the end of life.

#### **Pray About Constitutions/Votes**

With abortion advocates bolstered by the outcome of the Ohio election, many states could face votes to amend their constitutions to allow abortion in all cases, up through birth. Many of those could pass. This could undo many of the pro-life gains in recent years. Lies are often told, pro-abortion campaign funding tends to be 10x the pro-life campaign funding, and the wording is vague, which helps it pass. It's bad enough with a few lawmakers or judges inflict widespread allowance of killing, but when the people vote for it, this can cause grave harms.

#### **Pray About Legal Challenges**

There are several states with legal challenges that could make a big difference if judges/justices end up siding with protecting life. The laws were passed to protect life, and it would help if people prayed for good outcomes.

If the pro-life side prevails in the states of Arizona, Utah, and/or Wyoming, then those states will provide full protections throughout pregnancy. If the pro-life side prevails in the states of Iowa and/or Florida, then those states will provide protections from the moment a heartbeat is detectable.

The farther a woman must travel to get an abortion, the less likely she is to get an abortion. This seems intuitive, but is also backed up with statistics. Thus, the more states that add protections for life, the better the overall outcome will be.

There is still much to be done to protect human lives in our laws. We hope our states and nation will do what is right.

The Iowa Caucuses are coming up in January. While we don't support candidates or parties, we can promote civic involvement.

Caucuses allow political parties to accomplish some of their party's business at the precinct level. The most well-known part of the process is the Presidential preference. This is where members of a political party identify who they prefer to be their party's candidate for the general election later in the year. Since caucuses are managed by the parties, and thus they control the processes used by their party. Thus, the parties tend to differ in how they go about this process.

People can also submit planks that could form the party platform at the various levels of the party. I would love to see pro-life planks appear in each party. Some people may avoid submitting planks that they run counter to their party's recent platforms. However, I've encountered a variety of things in my life.

I'll point out something regarding both of the two largest political parties. When I was young, if someone wanted to represent my hometown in the state legislature, then they had to be a Democrat. However, they also had to be pro-life. If either was not true about the candidate, they had almost no chance of winning. I also think about how the national Republican platform tends to include support for the death penalty. However, over a decade ago, the county party had someone challenge that, and it hasn't been in the Republican platform at all in the past decade at the county level.

Parties have generally chosen one side or the other on issues, but they can change or allow variations at the local level. Local stances work their way up to the state and national party platforms. Parties are meant to reflect their members, rather than dictating what their members must believe.

The caucus also allows people to fill positions that gather the precinct platform planks to generate the county party's platform. There are other roles that one can fill, too. There is more to the caucus that who you want as President. Engage!
